B. Prospects for Profits and Losses

Market expectation

A Knock-Out Warrant Put (closed-end) offers the possibility to benefit from changes in the prices of the Underlying with a leverage effect. Investors in a Knock-Out Warrant Put (closed-end) expect the Underlying price to fall.

Risk tolerance
