A Knock-Out Warrant Call (closed-end) has a fixed Redemption Date. If the Underlying reaches or falls below the Strike Price at any time during the life of a Knock-Out Warrant Call (closed-end), the Knock-Out Warrant Call (closed-end) expires immediately and the residual value is zero.
