A. Product Description

It can be used as speculative instrument or for hedging purposes. With a Knock-Out Warrant Call (closed-end) the Holder profits from rising prices of the Underlying. A Knock-Out Warrant Call (closed-end) has a fixed Redemption Date. If the Underlying reaches or falls below the Strike Price at any time during the life of a Knock-Out Warrant Call (closed-end), the Knock-Out Warrant Call (closed-end) expires immediately and the residual value is zero.

B. Prospects for Profits and Losses

Market expectation

A Knock-Out Warrant Call (closed-end) offers the possibility to benefit from changes in the prices of the Underlying with a leverage effect. Investors in a Knock-Out Warrant Call (closed-end) expect the Underlying price to rise.

Risk tolerance

Due to the leverage effect, the value of the Knock-Out Warrant Call (closed-end) will fluctuate more than the value of the Underlying. An investment in a Knock-Out Warrant Call (closed-end) therefore bears a higher risk than a direct one to one investment in the Underlying. Investors in this product should be experienced investors being familiar with derivative products, leverage and the Underlying. Investors are willing to take a higher risk compared with a direct one to one investment in the Underlying in order to achieve a higher profit potential.

Profits potential

A Knock-Out Warrant Call (closed-end) benefits disproportionately from a positive price performance of the Underlying. The profit potential for a Knock-Out Warrant Call (closed-end) is unlimited.

Loss potential

Holders may lose some or all of their invested capital but the maximum loss is limited to the initial capital invested. A Knock-Out Warrant Call (closed-end) has a fixed maturity, but in case of the occurrence of a Knock-out Event, the Knock-Out Warrant Call (closed-end) will be automatically early redeemed at an amount equal to 0 (zero).

The risk for an investment in a Knock-Out Warrant Call (closed-end), which is significantly greater than it would be for a direct one to one investment, is based not only on the leverage effect, but also on the occurrence of a Knock-out Event. Please also review the Early Redemption and Issuer and Guarantor Risk factors below.

General
